In February 2021, Humanitarian Fraternity (FIHM) was also invited to join the global body of focal points of INEE. Aside from the worldwide visibility of FIHM's genuine attempt to contribute to get the Sphere Standards to Portuguese-speaking nations, INEE's Portugal representative approached FIHM who embraced the challenge. Since then FIHM has been both improving the services it's been providing since 2011, reinforcing the application of international standards, and training hundreds of FIHM steady collaborators, agencies, institutions, corporations, governments, professionals, etc.

Since May 2020, in contact with Cathy Watson of LEGS, nevertheless, due to the FIHM priority service demand vs. mobilization cost vs. volunteer staff available to respond to all, FIHM has been following up on LEGS standards and initiatives, but not directly involved.
